Dear Collegues,

as most of you know the meeting recently held in Crete has celebrated the 20th anniversary of the Seven Countries Study.

The galley proofs of the 10 year monograph seen by some of us ha indicated the happy conclusion of the 10 year experience and of the first act of such exciting study.

The plans for the future, that is a "Second Edition" of the Seven Countries" are being set down by Dr Blackburn, starting more or less with the 20th anniversary examination in most areas. If a financial plan will be obtained much interesting work shall be offered to all of us.

As repeatedly suggested by Dr Keys there is however an important piece of work and analysis still to be done as an intermediate activity between the two trunks of the Seven Countries; that is the 15 year experience for mortality which should be available from all areas.

All of you may know that I have been responsible for processing and coding all the causes of death of all areas (except US Railroad) and that presently copies of tapes with the 10 year data are available also in Rome and ready for analysis on suggestion of Dr Keys.

After the 10 year anniversary all areas have collected some death cases but there is no assurance that they are all and complete, i.e. that for all men, at the 15th anniversary, the status in life or death and the cause of death have been individually checked. Clearly, in view of the 15th year analysis it is important to have this point checked and the Minn. Form 10 filled for each case of death.

This is a formal invitation to complete the collection of such data, to check very carefully all fatal events for the period included between the 10th and the 15 th anniversary and to send me what previously has not been sent(either to me or in Minneapolis, care of Mrs R.M. Hilk).

It would be useful to receive such material and a statement about the completeness of the live-dead scrutiny by mid December.

For your help you shall find enclosed here the list of men of the area(s) of your responsiblity dead between the 10th and the 15th anniversary as available in Rome.

Standardization and coding of causes of death

- -The Rome Group will be ready to assume responsibilities in coding death causes and possibly also of non fatal events.
- -It is proposed to employ revised versions of Minn. Forms 10 and 20. Form 10 should be accompanied by a compulsory check list of questions (already available) which are to be asked to the witnesses of the event.
- A comparability with the data collected during the first 20 years should be assured.
- -A methodological study on the comparison between the 8th and the 9th edition of the ICD is necessary at least for those cardiovascular conditions which have been mostly coded in the past.
- -A review and possibly enlargment of the LPH codes for prevalence, incidence and mortality might be useful provavided comparability the the past codes might be obtained.

THe E.C. should be made of 3 people. It should consider (and make?) proposals for paper on the main issues of the study, assigning tasks and establishing the rotation of senior authors.

Moreover it should receive the requests for analysis by investigators particularly interested in special fields, evaluate them and put "the order" to the computer center.

The EC should review the texts prepared by the senior author of each paper involving data of the whole study and put it in the final version, including the linguistic problems.

The EC should be notified about papers concerning only local data and local analysis and give advice on request.

A reasonable timing in preparing and reviewing papers should be established.
