Enclosed is the information we would like to obtain from the medical history and physical examination in the Crete 5 year follow-up.

It would be worthwhile to have Sections A, B, C, & D translated as closely as possible into Greek. I would like a copy of the translation, as, I'm sure, would Geoffrey Rose, London School of Hygiene.

After the standard questions and responses are recorded, the examiner is quite free to pursue the history in any way desired. His overall clinical impression is recorded at the end of the physical examination.

Dr. Keys is writing in regard to other details. Please let us know promptly the recording equipment available for ECG work. We would consider having Mohacek bring a 2-channel spare Elema. The Cardiopan seems so reliable, and with only 3 channels it avoids the problem of attenuation when low impedance central terminal networks are thrown in with the limb leads. I could conceivably bring the Cardiopan from Italy.

I would plan to come to Athens a few days early to help you with the technicians' and clinicians' training for the field. Let us know the dates as soon as possible.

And of course, we are counting on your good collaboration there. An Agreement, enclosed, covers finances; please sign and return three copies promptly, and retain one copy for your files.

I have asked Dr. Aravanis to send you at once an invitation letter to help with visa, etc. No doubt he will tell you just when you should arrive in Athens and he will reserve a seat on the 'plane to Iraklion.

Herewith is a copy of a lotter to Dr. Lamm. Note that Dr. Gyárías will need a letter from you inviting him to take part in the work in Grete. Unfortunately I do not know Dr. Gyárías' first name; his address will be the same as that of Dr. Lamm. When you write to Dr. Gyárías, you should state that his expenses in Greece will be covered by guarantees from me.

I am at once checking to ensure that Dr. Mohacek will, as previously promised, aid in Grete. But please send him a note of invitation without delay so that he can obtain the visa, etc. I hope he can bring with him the Elema Mingograf from Zagreb and am writing him, copy enclosed, about various details. Note that he will probably be unable to bring an adequate supply of recording paper and ink. I am prepared to pay for the costs of those supplies but you should order what is needed for delivery in Athens in good time.

Either Dr. Blackburn or I will bring the hematecrit and will plan to leave this in Greece for the work next year in Corfu.

For the respiratory tests, your Collins machine will do. We hope that it will provide a timed record trace so that the 3/4 second expiration etc., can be measured as well as vital capacity.

In regard to the rather large extra funds you indicate will be needed, I eaclose an Agreement which you should have signed by Dr. Lekos, returning four signed copies to me without delay. And please advise how and where the money is to be transmitted. Note that I am arranging that the total of \$6,000 be paid in three installments, \$2,000 as an advance before the work actually starts, \$2,000 to be paid by September 15, 1965, and the final \$2,000 to be paid upon receipt here of the accounts, including receipts for the expenditures up to a maximum total of \$6,000.

As soon as possible, please advise precisely the dates planned for the Crete work. Dr. Blackburn should arrive in Athens several days before. Margaret and I hope to arrive at about the same time and would plan to leave Crete at the end of the first week of the actual field work.

In regard to E.C.G. and pulse wave recording machines, I think it may be very difficult to get the Cardiopan to Greece and back to Italy where it legally belongs. We can get a certificate of temporary export from Italy, I presume, but what about import into Greece? I would be willing to leave the Cardiopan in Greece until completion of the Corfu job next year, but what about your Gustoms?

My machines is a 3-Channel Siemens "Cardiopan" complete with accessories. This machine and accessories are packed in a trunk, some $50 \times 70 \times 100$ cm., and the total weight is about 70 kg. The value is about \$3,000 and it is the property of the University of Minnesota.

Unless we have assurance that we can bring in the Cardiopan and get it out of Greece again, I believe the only practical answer is for you to arrange to rent whatever you need from Siemens or another agency in Athens. Henry Blackburn likes the Cardiopan and insists that multi-channel machines should be used. I shall be prepared to re-imburse you for rental costs, provided these are not wholly exorbitant.

Excuse the long letter but I hope I have covered everything at issue at the moment.

Dear Henry:

The mistery of the never-arriving forms of the 1963 Yugoslav survey seems to be not a mistery at all. On the basis of your letters and the recently received results, the present situation is something like this:

(1) The physical examination forms and the follow-up medical history forms, both completed in 1963 and 1964, ought to be in Minneapolis. The information about the missing follow-up and medical history forms requested by you in your letter of July last, was sent to you in my letter of July 31st.

(2) The ECGs taken in 1963 are also with you. ECGs taken in early spring 1964 were sent to you in July 1964, but this shipment was never confirmed by you. Could you please check it? (The numbers of the subjects whose ECGs were taken in 1964 were sent to you in my letter of July 31st, 1965. Please let me know whether these ECGs are in your lab.

Now, the misunderstanding about the lost forms is actually related to the forms "Initial Record; Data for International Deck No 1". However, we have never used these forms in our work in Yugoslavia. The data concerned are, however, available from other sources, e.g. data on changes of occupation, physical activity and smoking were sent to you on the microfilm, already received by you, whereas the the data on hematocrit and urinary analysis of protein and glucose are attached to this letter.

Regarding International Deck No 2, the data on height and weight as well as the sum of skinfolds were also sent to you on the same microfilm while the data on vital capacity will follow in a few days.

The ECGs taken on younger people in Makarska and Dalj were also shipped to you last year.

I would appreciate your early comments.

Also included are materials about the data obtained in the 1963 follow-up. We are auxious to put on punch cards these long-delayed data. Norris Schulz has used as much as possible of the materials you sent on film strips but one of the three strips was of such quality that we believe the only thing to do is for you to provide the data in a new tabulation.

Including the materials we received a week or so ago, what we now have is the following for the 1963 examinations.

- 1) Clinical data and ECG. These are complete and on punch cards.
- Annual Serum cholesterol values from analysis here. These will be entered on the punch cards with the other data for Deck 1 when these last are available. Carlosare

The staff here have taken from these films all they can securely read but many records are partly or totally illegible. We are sending you prepared forms to be completed in Zagreb and returned here as soon as possible, to cover the unusable film records. Bill Parlin is providing, with the forms, notes for your guidance.

We have no respiratory function data though I understand that these were all assembled by Dr. Vukadinovic long ago. These data (vital capacity and 3/4 second expiration) are needed for punching cards and analysis. I see from your letter to Dr. Blackburn that these are forthcoming.

We discussed the question about obtaining information about blood relatives among the study men in Dalmatia and Slavonia. Such data were obtained in Crete this fall and will be obtained from Crevalcore and Montegiorgio soon, I believe. I enclose a copy of the form used for Grete and, reparately, we are sending tabulating paper for you to use similarly when and if these data can be obtained. At the very least it should be possible to find brothers in the cohort. Such data would be valuable in assessing the role of heredity in regard to anthropometric variables, blood pressure, serum cholesterol, etc.

However, it will be necessary to have the details as given in the heading and right-hand column of the enclosed form on the causes of death. Your listing failed to provide the month and day of death, the source of the death information, and the details on the three cases of sudden death. For the latter three cases, a narrative report as well as estimated time interval from onset of symptoms to death is helpful, to document whether they best fit the sudden unexpected category.
